Several meters have been exchanged lately, mostly due to sales of homes. The last lead test at well #1 came in at 4ugl. Previous was 1ugl. Not serious yet, but also not ideal.

Sewer. Pump #1 at lift station #1 needs repair. Pumping numbers are average considering the weather.

Public Works/Road repair. Russell provided the board with an update including requests for bids on mower broom and snow blower, as well as the tree service.

Recycling & Solid Waste. Jill provided a summary of the Recycle Center activity, which included 122 small and 57 large tickets sold for a total deposit of \$236.00 for the month of November. She is still waiting for an estimate on the new sign for the recycling center. Another recycling dumpster was ordered for the holiday season, and the heat has been turned on.
