Motion carried.

# Municipal Wells

Motion by (Carli/Bullerwell) to approve the contract and award Traut Companies the Municipal Wells project for \$267,620.00 contingent on PSC construction authorization receipt, WDNR/ACOE general permit approval, completion of public comment period to run until March 18, 2017, contingent on attendance at pre-construction meeting on April 3, 2017, at 1:00 p.m. at the Village of Radisson Hall and with the contingency that there will be change orders coming. Motion carried.

### Well House

Motion by (Carli/Bullerwell) to approve the contract and award Spring Lake Contracting, Inc. the Well House project in the amount of \$603,000.00 contingent on PSC construction authorization receipt, WDNR/ACOE general permit approval, completion of public comment period to run until March 18, 2017, contingent on attendance at preconstruction meeting on April 3, 2017, at 1:00 p.m. at the Village of Radisson Hall and with the contingency that there will be change orders coming. Motion carried.
