- Community Center/Emergency shelter funding/grant application is dormant.
- USDA-RD water system improvements project is still pending and the Village hopes to move on this this part of the new construction plan, until such time as FEMA makes grant money again available for a shelter.
- The Korthoff estate is to be given final notice and additional 5 days to bring the motel property into compliance with Village ordinance.
- Village properties to be razed is still pending Dan Sheehan return from out-of-state business.
- Shelley Wortman made a motion to approve the 2022 budget, the motion was seconded by Amy Bullerwell and the budget was approved subject to the Public Budget Hearing. The Public hearing is scheduled for 11-8-2021 at 4:45 p.m. to 5:00p.m. at the Village Hall.
